2019 was another year of tremendous growth at Nick Finnegan Counseling Center. We worked with more clients than ever, had our largest volume of counseling sessions and hired new team members to help serve our increasing client base. Notably, this was the first year in our history that we had a steady client wait list for the entire year. While this shows us that people know about NFCC and find our counseling services beneficial, it also confirms that the demand for mental health services is still increasing. This empowers us in continuing to increase our efforts to help as many clients as we can. While mental health has become a regular subject in mainstream conversations, seeking counseling services still holds a certain stigma. Texas still ranks last in access to mental health care in the United States. In fact, according to the National Alliance on Mental Illness, the Harris County Jail remains the largest mental health institution in the state. We dream of a day when that statement is no longer true. That's why our team works hard to chip away at that stigma by making our counseling center a place that people feel comfortable telling others about and are willing to refer their friends and family. NFCC prioritizes outreach efforts to offer mental health support in the community through preventative education tools, support groups and trainings, in addition to the quality services we offer on-site. Our outreach talks are beneficial in helping others identify their mental health needs, as well as how to begin the process of seeking help.

OUR MISSION

Nick Finnegan Counseling Center strives to provide affordable and accessible counseling services to anyone regardless of differences such as age, finances or beliefs.

Mental health treatment is as imperative as ever and the Nick Finnegan Counseling Center strives to be a part of the solution in the Greater Houston area. NFCC is able to reach a wide clientele because we offer affordable private pay rates, work with five insurance providers, offer a need-based sliding scale and have a diverse staff with a wide range of specialties. As our robust client growth continues to increase our annual budget, we strive to stay ahead of the curve by strategically planning for our future and anticipating growth. As you'll see in this report, we simply could not fulfill our mission and offer high quality care without the support of our generous donors and dedicated advisory board. While our primary service is on-site counseling, I suspect that next year's annual review will highlight our expanding community outreach initiatives and the establishment of The Nick Finnegan Counseling Center Foundation. Exciting things are in the works! I hope you will be there to watch them unfold.



DONATION BREAKDOWN




INCOME BREAKDOWN

Thanks to **The Fondren Foundation** our counselors received over 300 CEU hours in the past 3 years.

It costs NFCC \$175 per counseling session, yet our private pay rate is only \$95. Our average revenue per session in 2019 was \$68.

our partnership with **COMMUNITIES IN SCHOOLS**

In 2019, NFCC expanded our partnership with Communities in Schools (CIS) to send counselors to four high risk schools. CIS helps determine the schools with the greatest need and identify students with referrals from school principals, teachers and parents. Many of the students' only access to mental health support is through this partnership. Several of the students are struggling with issues that affect basic needs such as safety, food and shelter and our counselors are able to help these students cope through extreme life challenges and provide a consistent supportive presence. Thanks to a grant from the Powell Foundation and support from CIS, NFCC counselors are currently providing services at Edison Middle School, Westchester Academy for International Studies, Shadow Oaks Elementary School, and North Brook High School. Each counselor is placed at one school for the entire school year and provides roughly six hours a week of mental health services on that school campus - in addition to the clients they serve at NFCC.
