The Nick Finnegan Counseling Center is passionate about making our community a better place by reducing the stigma of mental health counseling and guaranteeing that counseling services, outreach programs, professional trainings, and support groups are affordable and easily accessible. According to Mental Health America's 2022 Report on the State of Mental Health, **Texas ranks last in access to care.** Specifically, our state is lowest in the nation regarding access to insurance, access to treatment, quality and cost of insurance, access to special education, and workforce availability. Awareness of, access to, and affordability of community mental health resources are three major players in determining whether a person can get the support they need during times of increased stress and NFCC prioritizes all three. The National Alliance on Mental Illness also shares the staggering statistic that **50% of all lifetime mental illness begins by age 14, and 75% begins by age 24.** This highlights the immense need for our community to have a place like NFCC, which serves children as young as three all the way through adolescence and adulthood.

Expanding access to mental health services is and always has been fundamental to NFCC's mission, and we do so by offering insurance options, a sliding scale, and a low private pay rate of \$95. The *Because Counseling Matters Fund* helps support those payment options so that no one is ever turned away due to finances.

While one-on-one counseling services remain our primary focus, we have worked hard the past few years to increase our outreach to the community. In 2021, we introduced a new podcast, *"Through the Seasons of Mental Wellness,"* expanded our counselor talks to new organizations and businesses, and continued our partnership with Communities in Schools to ensure students with few resources were provided access to counseling.

The link that connects every individual involved with NFCC is our passion for making this community a better place. Our growth over the last decade is a testament to the dedication and commitment we have to our community as we continue to reach more people and offer mental health services that will have a lasting impact.
